#### **Bexar County Probate Court No. 1<sup>1</sup>**

One of the statutory probate courts hearing wills, estates, and guardianships.

#### **Bexar County Probate Court No. 2<sup>1</sup>**

Second statutory probate court with the same jurisdiction.

#### **Bexar County Clerk — Probate Division<sup>2</sup>**

Filing office and clerk of record for probate cases.

#### **Courthouse complex**

#### **Electronic filing<sup>3</sup>**

Attorneys must e-file through the statewide system.
